In this Winter 2012 issue, *JHNA* is pleased to publish linked technical studies on the paintings of Cornelis Engebrechtsz, Lucas van Leyden, and Aertgen van Leyden. These two articles, by Esther van Duijn and Jessica Roeders (jointly) and by Abbie Vandivere, resulted from research conducted for the University of Amsterdam's Impact of Oil project. Michele Packer's article, concerning the ways images of recently demolished seventeenth-century buildings served as collective memories, expands a paper that she presented at the last Historians of Netherlandish Art Conference in Amsterdam, held in May 2010. A short archival note by Gero Seelig on the purchase of Carel Fabritius's *Sentry* rounds out our offerings. Please note that in addition to longer articles, *JHNA* has initiated a policy of encouraging shorter essays on archival discoveries (as in the current issue), iconographical issues, technical studies, and rediscovered works. Photo essays with commentary are also encouraged. We welcome your suggestions.

During the last few months, we have made several technological improvements to our website, most importantly moving it from one webhost to another. This necessitated a temporary shutdown in November, for which we apologize. We hope the new service will, among other things, enhance the search function for *JHNA* articles as well as the linking of our articles.

JHNA is archived by Portico, an electronic service initiated by JSTOR and supported by the Mellon Foundation, Ithaca, and the Library of Congress. Our membership in CrossRef allows us to register our articles, each with a Digital Object Identifier (DOI), so that libraries and other organizations can find these articles and create links to them.

We encourage you to consider *JHNA* as a venue for your own publications. With your help, *JHNA* is becoming one of the premier journals of Netherlandish art. The next formal deadline for submission of articles is **March 1, 2013** (for publication in 2013), although we welcome submissions at any time.
